Sharing your personal data

Retention of personal data

We keep your personal data for 5 (five) years. Fin2Grow is required to keep all records during this period for administrative, legal and security purposes.

Securing your personal data

All our partners are responsible for the security of your personal data. They provide databases with the necessary encryption, take hardware-level security measures and also have a security policy related to access to their locations.

Procedure datalek

If there is a data breach or theft of data, Fin2Grow will notify the following authorities in order to limit the leak and/or theft.

- Police

- The victims

Fin2Grow will take the necessary measures to close the leak as quickly as possible in the case of a data breach or data theft. Since Fin2Grow only has limited personal data (name, first name and email address), it is not mandatory to report to data protection authority within 72 hours.
